

Yavanai Soccer Club Select Coach Agreement

Revised 2025

Responsibilities

- The Coach is responsible to set the standard of orderly conduct on the field and to control the actions of all coaching staff, players and spectators present who are associated with YSC.
- Coaching positions are approved annually at the discretion of club directors.
- The Coach probationary period is up to 3 months. Conduct during the probationary period will determine a coach's status. The revocation of coach status may be done without cause.
- YSC coach meetings are mandatory.
- Coaches, Assistants and Team Managers must complete all clearance steps, pass an annual ASA background check and sign this Coach Agreement before contact information and field access is granted.
- The Coach agrees to lead organized weekly team training sessions and be present at all team activities. If attendance is not possible, an approved substitute coach must be appointed.
- Training sessions must be run in a positive, structured, professional manner with a session plan.
- The Coach will be evaluated and mentored regularly by the DOC.
- Coach disciplinary action can be taken for any reason including misconduct, mistreatment, mismanagement, absence, dereliction of duties or violation of the policies outlined in the agreement. (See "Penalties" below).
- The Coach is responsible for knowledge and compliance of the laws of the game as defined by YSC and ASA/USYS.
- The Coach will be required to wear Yavapai Soccer Club approved coach wear at all team sessions and matches.
- All coaching and club equipment must be returned upon a coach's departure from the club.
- Select Coach pay is a tier system based on the US Soccer license and experience. (See "Compensation" below)
- A YSC director must be included and listed as Owner of team group chats.

Coaching Education

- Coaching requirements are approved by the DOC and are as follows:
 - Head Coaches of U10 and below must hold a US Soccer "Grassroots" License.
 - Head Coaches of U11 and above must hold a US Soccer "D" License.
 - Further education may be required at discretion of the DOC.
- Coaches should pursue coaching education at all available opportunities including on-field mentoring, coach meetings and curriculum.
- Reimbursement for coaching education expenses is at the discretion of the club.
- YSC Coach meetings are mandatory.

Teams

- Tryouts, evaluation sessions, team formations, age exceptions, Guest and Club Pass Players are to be approved by the club.
- All teams must use the club-approved Select program uniforms.
- The coach may recruit a Team Manager to assist with team communications, fundraising and general help. Team Managers are approved by the club.

Fields and Scheduling

- All fields, facilities and season's schedules must be requested and assigned by the club.
- All Select activities during summer break must be approved. Summer break begins at Tryouts (May), and ends on August 1.

Team Finances

- Each team shall maintain a financial account with the YSC Director of Finance.
- Team funds shall be disbursed according to the requirements and approval by the Director of Finance.
- Teams may perform approved fundraisers and solicit sponsorships. Any donations to the club/team must be submitted to the Director of Finance.
- Player fees are determined annually by the YSC Board according to the approved club budget. Fees are collected and supervised by the Director of Finance.

Player non-payment or late payment will risk their eligibility.

Player Registration

- The Coach is required to maintain and have in their possession, or in their absence an Assistant Coach's possession, at all team activities, accurate records of all player passes, registration forms, medical releases, parent / quardian and emergency information.
- The coach will present YSC- provided player passes to the referee or field marshal prior to the start of each ASA-sanctioned game. The passes shall be returned to the coach at the end of the game. If a player or coach was ejected, his/her pass is submitted to ASA.
- The coach is required to safeguard the personal information of each member of YSC and not use it for any reason that is unrelated to the organization. Violation of this agreement may result in legal action.
- If a coach utilizes an unregistered or illegally registered player, disciplinary action may include coach suspension and/or forfeiture of games in accordance with ASA bylaws.
- All player loans out-of-club must be approved.
- Players may be removed from YSC for non-payment of fees, and violation of the code of conduct and other circumstances.

Penalties

- Complaints regarding coaches must be submitted in writing and will be reviewed by the club.
- The penalties or disciplinary actions for non-compliance with the above guidelines are enforced according to the following order:
- First offense: Warning, written acknowledgement,
- Second offense: Coaching counseling, suspension and/or financial consequences,
- Third offense: Potential for removal from the club.

Duration

This Agreement shall cover the following periods:

Commencing on <u>March 20, 2025</u>, and ending on <u>April 30, 2026</u>. Either party may terminate this Agreement upon written notice to the other party.

Renewed approval/appointment is subject to review by the Executive Director and Director of Coaching.

Compensation

Head Coach (U11-U18 age brackets): for the months of the team's season.	
USSF Grassroots: \$500/ month	
USSF D license: \$650/month.	
USSF C license: \$950/month.	
Head Coach (U9, U10 age bracket): for the months of the team's season.	
USSF Grassroots : \$350/ month	
USSF D license and above: \$450/month.	
Assistant Coach (U11 and older)	
\$500/season for one Assistant Coach.	
Tournament Stipend: depending on team funds.	
\$300 for the Head Coach.	
\$200 for one Assistant Coach.
